Note: Thanks to those of you who notified us about this DCW phishing scam as it is an important defensive move to help protect us and our members.



Because some of our members have recently received phishing emails from either Bettie Asip or Suzi Modisett as DCW Co-Presidents, claiming "Delta Clipped Wings needs some gift cards for donation to Veterans at Hospice and

Palliative care units for preventive items from Corona Disease (COVID 19)," we thought it was wise to remind everyone to be diligent when responding to emails.

Our short advice is to look at the email address from the sender **BEFORE** you consider responding to any message you think is from one of us at DCW. Take a look at the following email addresses that appeared in these phishing emails:

The **Subject** field was **Delta Clipped Wings**

From: Bettie Asip <referenc@onnansor.com OR From: Suzi Modisett <references@commanacan.net

You don't think they look suspicious? Well, they are, and you can do your part by reporting anything suspicious. Ways to report:

- Let the person you recognize (using their real email address) know, so they can let their friends know it is a SCAM.
- Report the phishing attack to the FTC at ftc.gov/complaint.

BEWARE: Scammers use email, text messages and phone calls to trick you into giving them your personal information. Again, in the environment we live in today, we all need to be very diligent in protecting our privacy.




